Prosecution and reporting The first recorded law on paedophilia was passed in England in 1861, with the current law mostly in response to a number of high-profile child sex abuse cases. In 2000, the three-strikes law enacted in California was amended to include online child pornography. In India, the Child Exploitation Prevention Act of 2009 was enacted in June 2009. In Belgium, a law passed in 2011 increased the penalties for "virtual child pornography" (corresponding to child pornography hosted on a computer) to life imprisonment. The law also introduced the possibility of an extended prison sentence for images of the sexual abuse of a minor. Offences Possession of child pornography is illegal in most countries. There are exceptions, for example the European Union, where possession of child pornography is not an extraditable offence. In 2013, according to the National Center for Missing and Exploited Children, within the United States, 44% of prosecuted cases had a victim under age 12. The rate of sexual exploitation of children is estimated to be between 4% and 25% globally. Despite this, researchers estimate that child pornography on the Internet is only a small fraction of the total. Among the most common offences in the US are violations of the Child Protection Act of 1978, which prohibits possession of child pornography, and the Wiretap Act, which makes it illegal to use an electronic communication device to distribute child pornography. Australia In Australia, the main laws dealing with child pornography involve the Protection of Children from Sexual Assault Act 1990, which makes the possession of child pornography illegal if the offender has previously sexually assaulted a child. Canada In Canada, the main law currently used to prosecute those who use children in child pornography is the Criminal Code of Canada Section 163.1. While not referred to as "child pornography", material depicting the sexual abuse of minors is illegal. This type of possession is subject to a mandatory minimum sentence of six months in prison, which can only be served while the person is completing a sentence for a serious crime.
